





Evidence statement Local Green Spaces

1. The Penzance Neighbourhood Plan Questionnaire included the following questions -

Q19 There will be a protected green infrastructure; a network of open and green spaces, *linked by paths, bridleways, green lanes and cycle ways across the parish;* and

Q20 Public open spaces will be protected from development.

More than 90% of respondents agreed or agreed strongly with both statements. Results from the Questionnaire questions are attached as Appendix A.

In addition the audit of local green spaces identifies the support and involvement of local residents in different parts of the town or specific villages through formal and informal groups.

2. In line with national and Cornwall Council guidance an audit of green spaces in Penzance Parish was carried out based on Cornwall Council's Local Green Spaces Audit Form (*Source: Local Green Space and Green Infrastructure guide note (for neighbourhood plans*)).

The sites included in the audit were identified initially from Cornwall Council's Penzance & Newlyn Town Framework Open Space map (Appendix B) with additional sites within and outside the Framework area identified from community representations. Cornwall Council's Open Space Strategy for Larger Towns identified a lower than typical level of natural space in Penzance/Newlyn and a lower than average provision of outdoor sports space.

The sites were included because of their importance at a local community level in terms of amenity, visual and biodiversity values; they include parks and gardens, amenity green spaces, natural/semi natural green spaces, sports pitches (public access), equipped children's play areas and provision for teenagers, allotments, Churchyards and school/club sports pitches. Some provide a tranquil space or an opportunity for meeting or play; others contribute to the quality of the urban or village environment. Even very small amenity spaces make a significant contribution to the environment of residential areas.

Many of the sites have potential for increasing biodiversity. School and club pitches may have the potential for wider community use in an area where Cornwall Council has identified a shortage of playing pitches.

Together with green pedestrian and cycling routes and biodiversity sites and corridors, the sites contribute to the Green Infrastructure Strategy for the plan area and to key aspects of the GI strategy in the Cornwall Site Allocations DPD. Links between the sites and green routes, the Cornwall Coast path (South West Way) and biodiversity sites and corridors are important in this respect.

3. Audit forms for each settlement are included in the evidence base; sites identified in the Town Framework map, such as civic spaces, play areas or sports courts, which are not green spaces have not been included and are protected for recreational or community use by a different policy in the Plan.

4. Maps showing the sites carried forward in Policy GI1 of the Neighbourhood Plan are included in Appendix 10 of the Plan, Local Green Spaces; corresponding reference numbers have been added to the Audit forms.
