





A big car park, some boats, a busy road, dwarfed by Wharfside with a few shops and cafe's struggling to compete with the noise and fumes of the street. Again sign posting to direct people towards the waterfront or high street would be good, making use of the smaller roads and alleyways between places that are often neglected. Here's an idea for the Harbout Car Park: The Penzance Boardwalk - Crab Shacks and Great Coffee! There is about 2000 sq metres of unused space right beside the car park, overlooking the boats in the drying harbour, bathed in sunshine all day. Its the car park revetment - a sloping ramp of concrete with a few sets of steps down it and the mooring lines of about 20 small boats. People sit and eat thier fish and chips on the low wall and enjoy the view which draws them to it. The view is just great if a bit rough and ready - the harbour, boats, water, granaite quays, the tumble of houses down the headland above the working Dry Dock, you can feel the sea. This is Penzance. The Boardwalk could be a simply constructed platform on pilings almost 200m long and 10m wide, a terrace with crab shacks and small indepenendent cafe 'sheds' on it selling great local produce. Get Harverys Shellfish to run one! It barely needs to impact on the car park, in fact it works with the car park; arrive in Penzance car park - you're somewhere already and its just great The Boardwalk venues can turn around too so that they are an instant facility for outdoor events making a venue of the car park It might be a stepping stone to redefining the Harbour Carpark and Wharfside as a public space that you might want to dwell in It might also help re-organise the boat storage - at present each winter the small craft in the harbour are craned out over the revetment onto the car park.
